1 Defendant nos.1 and 2 are present in court. At the same time, defendant nos.1 and 2 stated that they have not posted anything which is the subject matter of the suit in the recent past and they have no intention to precipitate the matter or post anything. nos.1 and 2.

3 Ms. Dholkia appearing for defendant no.5 undertakes to file vakalatnama within one week from today. Undertaking accepted. Ms. Dholkia states that the allegation in the plaint is that defendant no.5 owns defendant no.4 and defendant no.4 is under the control of defendant no.5, which is incorrect. Ms. Dholkia states that defendant no.5 has no control over defendant no.4.

4 As far as defendant no.11 is concerned, Mr. Shyamsunder states that Indian National Press Bombay Pvt Ltd. is the correct defendant and he will address a communication to plaintiffs for amending the cause title. Mr. Shyamsunder also undertakes to file vakalatnama on behalf of defendant no.11 within one week from today.
